Hi Emma

Sorry to introduce myself like this, I got your name from the Review of CG72 ADHD November 2011.

We are operating a Neurofeedback practice and are keen to engage with NICE in the upcoming review of the Guidelines.

I wanted to ask what the best way to do this was ?

We've done some preliminary work and I've attached two documents that I'd appreciate any feedback on – one explains how the American Academy of Pediatrics reached the conclusion to classify EEG Biofeedback (aka Neurofeedback) as a Level 1 Evidence-Based Intervention for Attention & Hyperactivity Disorders, and the other is a draft document making the case for Neurofeedback on the NHS on clinical outcome and cost grounds. In the latter we have estimated a potential cost saving of £320m over the next 5 years and would be grateful for any comment or guidance on this.

I'd be happy to come and meet you or your colleagues to better understand the consultation process and address any questions you might have.
